## **Dog Hotel Botz**

### **General Terms and Conditions of Business**

1. The dog holder confirms with his/her signature a valid vaccination for his /her dog against rabies, hepatitis , distemper, leptospirosis, parvovirus and kennel cough as well as a valid dog holder liability insurance. (The valid vaccination card incl. a copy of the liability insurance must be presented upon arrival)

The dog holder declares that the dog is not infected by worms, vermin and contagious diseases. For reasons of precaution, we kindly ask You to treat Your dog with a suitable agent against fleas and ticks. If necessary, we will perform this treatment at the expense of the dog holder.

In case of proven evidence that the dog is infected by a contagious disease, the holder of this dog shall bear the costs incurred as a result for disinfection and and co-treatment of infected dogs.

The last de-worming must not be further back than 4 weeks.

The dog holder is agreeable that in case of emergencies, acute illness and injuries, the necessary treatment shall be performed at a veterinary of our choice at the expense of the holder. For trips to the vet we charge an expense allowance in the amount of € 30,00 incl. 19% VAT

2.The dog holder also takes over legal owner responsibility for the entire duration of accomodation, i.e. for those damages which have been caused in the dog hotel and/or with third parties as well as with other dogs. The dog hotel shall be only liable for intention and gross negligence.

3. The dog food is to be provided by the dog holder upon arrival for the entire duration of the stay. The dog hotel reserves the right, if necessary, to switch the dog to an appropriate diet, and to invoice any additional costs (e.g. chicken and rice in case of diarrhea, soft canned food in case of teeth problems)

4. The dog hotel commits itself to treat and to take care of the dogs, to the best knowledge and belief, furthermore, to prevent accidents, in the best way possible ( according to animal welfare dog regulation ).

The dogs are not under permanent observation. The dog holder was given the possibility to get an impression of the circumstances on site.

5. The dog hotel shall not be liable for lost, damaged (torn) blankets and baskets, chewed collars as well as for toys.

6. Should the heat of the female dog be known to its dog holder, he/she shall be committed to inform the dog hotel accordingly.

In case of female dog in heat during the stay in the dog hotel, the dog hotel shall not take over any responsibility for possible consequences of a mating.

7. Should the dog holder not be able to pick up his/her dog at the agreed time, the dog hotel is to be notified in due time. In case of a non-agreed extension of the stay, we reserve the right to accommodate the dog in other spaces, should the dog hotel be fully booked.

If the dog is not picked up at the agreed time and if the length of stay was not extended by the dog holder, the dog hotel is entitled, after a transitional period of 8 days, to accommodate the dog at another location, respectively leave it in the animal shelter, at the cost of the dog holder.

8. A reservation for a booking in the dog hotel is only binding upon receipt of the completed contract as well as a reservation fee amounting to 50% of the total.

After receipt of the deposit, the booking is mutually binding.

9. Upon withdrawal of the contract within a period of less than 14 days prior to the agreed time of bringing the dog to the dog hotel, the compensation payment amounts to the total reservation fee.

In case of a cancellation of less than 5 days prior to the agreed day of bringing the dog to the dog hotel, respectively in case of earlier pickup, the compensation payment amounts to € 20 per day and dog.

10. The invoice amount is to be paid in cash minus the reservation fee when bringing the dog to the dog hotel.

In case of bank transfer, the amount must have been credited to our account prior to bringing Your dog to our dog hotel.

Should individual contents of the General Terms and Contents of Business be ineffective, the other contents of the General Terms and Contents of Business remain unaffected
